

Purpose

To make a decision regarding the filling of a vacancy on the Board.

Background

Following the Inaugural Meeting of the Hastings and Prince Edward District School Board on November 15, 2022, Katherine MacIver, Director of Education and Secretary of the Board, received notification in writing from Kristen Parks that she would need to resign her position. Kristen Parks was acclaimed from City of Quinte West Municipal Election for the area of Sidney and Frankford. As an oath had not been taken, this position is considered vacant and is now subject to Policy 3-H: Filling Vacancies on the Board.

Process

Notification of this vacancy was provided to the Governance and Policy Committee at the November 16, 2022 meeting. The members discussed the options to fill the vacancy according to Policy 3-H: Filling Vacancies on the Board. Options include holding a By-Election or an Appointment Process. A by-election would incur full costs to the board and considerable work for the municipality who have just completed an election. In addition, as this was an acclaimed position, there is no indication that nominees would come forward for a by-election.


An appointment process would be handled internally through an Ad-Hoc Committee with the support of board staff. As there were no unsuccessful candidates in the Sidney and Frankford election, an application and interview process would be the suggested method. With a 90 day timeline for an appointment process, advertising for the position could take place immediately and an Ad-Hoc Committee could be formed at the December 12, 2022 Regular Public Meeting of the Board with interviews scheduled for mid-January. This schedule would have the position filled for the January 23, 2023 Regular Public Meeting of the Board.






